

Transformation program

- Demolition program
 - Larger fenced zone complete, hospital area cleared progressing to houses outside the fence
 - Smaller fenced zone Widi Ngaruwa on site and progress is well underway
 - Commencing now TAFE building, new caravan park site, pony club, golf club, swimming pool, old BMX track, sub-station, archery club
 - Next tranche motorcycle club
 - Removal of fences
- Sales program
 - Residential final available properties will be advertised for sale recreation centre, town depot, houses
 - Commercial all available properties have contracts
 - Remaining properties church and visitor centre retained by OCA, Adnyamathanha properties
- Future rental provider










Draft Concept Design




