#### 6. OCA BUSINESS

The Members were provided with an update on the Leigh Creek and Oodnadatta aerodrome upgrade projects. The Department for Infrastructure and Transport (DIT) has provided a Memorandum of Administrative Arrangement (MoAA) and a Service Agreement for the OCA to execute, both of which exceed the delegated authority given to the Director of the Office for the OCA.

The MoAA is for State Government co-funding of \$578k matching grant funding approved by the Commonwealth under the Remote Airstrip Upgrade Program, Round 8 to reseal the two airstrips at the Leigh Creek Airport (\$500k) and towards animal proof fencing at the Oodnadatta Aerodrome (\$78k). The total value for these projects is \$1.156m.

The Service Agreement is for the OCA to engage DIT, Transport Project Delivery (TPD) to undertake the Leigh Creek Aerodrome runway resealing works with a toral project value of \$1m (GST exclusive).

In accordance with Treasurer's Instruction 8, approval is sought from the OCA to execute both the MoAA and the Service Agreement.

The Memorandum of Administrative Arrangement with the Department for Infrastructure and Transport for \$578,000 towards animal proof fencing at the Oodnadatta Aerodrome and the resealing of two airstrips at the Leigh Creek Airport, matching Commonwealth Remote Airstrip Upgrade Program funding for a total project value of \$1.156m.
- 2. The Service Agreement with the Department for Infrastructure and Transport for Transport Project Delivery to undertake the Leigh Creek Airport project works.
