4. ADJOURNED MATTERS

4.1 Regional Development Australia Far North Funding Agreement July 1 2023 – June 30 2028 – information update

The current resource agreement between the OCA and Regional Development Australia Far North (RDA FN) concludes 30 June 2023 and RDA FN is seeking OCA support to enter into a new agreement for a period of five years concluding on 30 June 2028.

The OCA agreed to execute a five year funding agreement based on the draft provided with Regional Development Australia Far North for a sum of \$51,000 indexed annually to CPI.

Member Wright joined the meeting at this time.

5. OCA BUSINESS

5.1 <u>Business Plan and Budget 2023/24 (Ref. N23-01/04)</u>

The draft Business Plan and Budget 2023/24 document was circulated for endorsement prior to the April meeting so that community consultation can commence, enabling it to be approved by the Minister by 31 May 2023.

The OCA approved for the Business Plan and Budget for the 23/24 financial year be released for consultation so that Ministerial approval of the budget for expenditure from 1 July 2023 is obtained.

5.2 <u>Connecting Communities – Intention to Partner: Royal Flying Doctor Service and Outback Communities Authority (Ref. N23 – 02/04)</u>

The OCA has previously approved \$500,000 of Local Roads and Community Infrastructure Program Phase 3 funds to be spent on wi-fi at 20 remote sites and 13 townships.

As a result of several meetings between the Royal Flying Doctor Service (RFDS) and the OCA staff a partnership project has been identified with the working title 'Connecting Communities'. An 'intention to partner' document was provided for the OCA to consider for an approach to deliver high speed public wi-fi across Outback SA.



Member Vaughan noted his conflict of interest and abstained from voting.

The OCA endorsed the further development of project scope and a partnership agreement between the OCA and RFDS to deliver high speed public wi-fi across Outback SA.

5.3 Local Roads and Community Infrastructure Grants Phase 4 (Ref. N23-03/04)

The Director proposed for OCA staff to develop a list of projects for the Board to consider once the funding amount for the Local Roads and Community Infrastructure Program, Phase 4 is known.

The OCA endorsed the proposed approach for allocating LRCI Phase 4 funding.

Member Johnson joined the meeting at this time.

5.4 <u>Development Process for the Next Strategic Plan</u> (Ref. N23-04/04)

The Presiding Member referred discussion to the Director who mentioned one of the focus areas in the 23/24 Business Plan and Budget being to develop a Strategic Blueprint for Outback SA with an action to consult and then publish a Strategic Blueprint for Outback SA that brings together the Authority's aspirations and vision, those of Outback Communities and the Planning Commission's regional plan.

It is proposed that an agenda, process, timeframe and comprehensive list of stakeholders be developed in partnership with the Department for Trade and Investment's Regional Planning Unit. The OCA's final Strategic Blueprint would not replicate the Planning Commission's regional plan but would include those aspects of it with potential for further partnerships and collaboration.

The OCA endorsed the proposed development approach for the next Strategic Plan.

5.5 <u>Leigh Creek Update</u> (Ref. N23-05/04)

The Presiding Member referred discussion to the Director who provided an update on the Leigh Creek township and its transition:

- Negotiating transfer of assets to OCA / community with the Task Force
- Urgent works to airport (new generator and electrical board) progressing this
 FY – approval of DIT procurement – budget adjustments occurring to take
 advantage of salaries underspend
- Paul Case (accompanied by Vicki Beard) will present to the Board at the June workshop (10am to 12 noon) and join Board members for lunch
- CCS negotiations on track
- Have requested Town Manager arrange for obsolete signage to be removed
- Further investigation required into the new health clinic regarding RFDS access

The OCA noted the Leigh Creek update.

- LRCI Projects all progressing Blinman campers' facility being brokered with DIT
- Will be on leave from May 8 12; Executive Officer on leave from tomorrow until 28/4 inclusive
- Attending the Local Government Forum for regional CEs at Berri on April 27 / 28
