5. OCA BUSINESS

5.1 Outback Roads Consultative Forum (Ref. N23-01/07)

The Members were provided with an amended version of the draft Terms of Reference for the proposed Outback Roads Consultative Forum that was updated following a meeting with the Minister for Regional Roads' staff.

The Outback Communities Authority endorses the requested changes to the draft Terms of Reference for the proposed Outback Roads Consultative Forum and requests the Director progress to the Minister for Regional Roads for their consideration, through the Chief Executive of the Department for Infrastructure and Transport, once they return to work in late August.

5.2 Blueprint for Outback SA Development Process (Ref. N23-02/07)

The Director tabled a proposed development process for a 'Blueprint for Outback SA' and the next five-year strategic plan for the Authority. This was identified as one of the focus areas in the OCA's 2023-24 Business Plan and Budget with an action to consult then publish a Strategic Blueprint for Outback SA that brings together the Authority's aspirations and vision, those of Outback Communities and the Planning Commission's regional plan. It is unclear yet whether the process the Planning Commission is going through will be suitable for the OCA.

The Outback Communities Authority endorses the proposed development approach for the Blueprint for Outback SA and the Strategic Plan, so that a project plan can be developed, and its implementation commenced.

7. PRESIDING MEMBERS REPORT

The Presiding Member participated in both CARM Policy online meetings. These had low attendance but participants contributed well during both meetings.

The Presiding Member also participated the first Far North Regional Plan Visioning Workshop initiated by the State Planning Commission along with the Director. Some of the outback maps used during the session were missing communities in the OCA region and the Presiding Member will seek to address this.

8. MEMBERS REPORT

Member Day reported her disappointment with low attendance for the Far North Regional Plan Visioning Workshop but appreciated the opportunity to participate. Member Day highlighted the diversity of the region during discussions along with requirements to be met to support any future population growth.

Member Day also referred to consultation by BHP on their planned Oak Dam next phase exploration program. Community members have asked for clarification on how BHP will support an increased working population when services like childcare are already under pressure.

Member Day is pleased to see that the Andamooka Homestead is being utilized by Kokatha to back to country education programs with a plan to branch into tourism with cultural experiences and education programs.

9. DIRECTORS REPORT

The Director's activities since the June 2023 meeting have included:

• Attending the Nilpena Ediacara National Park community open day facilitated by National Parks and Wildlife Services, Department for Environment and Water on Monday 17 July which included meeting and hearing Dr Mary Droser explain about the research being done at Nilpena to study and preserve the ediacaran fossils.

- Organising and attending Salesforce workshops on Tuesday 18 and Wednesday 19 July with all OCA staff involved to provide information required to develop the Customer Relationship Management System.
- Progressing recruitment for the Manager Policy and Community Affairs, Community Development Officer, Project and Administrative Officer and Field Officer Standards, Risk & Compliance positions.
